Driving pasture productivity

Progardes® Desmanthus is a pasture legume scientifically developed to improve and sustain your pastures. It is persistent, productive in clay-rich soils and naturally adapted to a broad range of harsh conditions.

Progardes® Desmanthus is a highly palatable source of protein, with excellent digestibility that converts to higher weight gains. Independent trial results indicate that tropical legumes such as Desmanthus help maintain pasture productivity resulting in more dry matter production and higher protein levels compared to grass-only pasture.

Keys to successful establishment

Prepare the best seed bed possible

- The better the soil seed contact and reduction in competition, the better the likelihood of good establishment
- Progardes® Desmanthus is a very fine seed (ranging from 180,000-240,000 seeds/kg) and should be planted on the surface of the soil and no deeper than 3-5mm

Sow when conditions are best for germination and establishment

- Sow with a good moisture profile and/or when there is a high chance of effective rainfall and follow-up rain. Soil moisture should be tested down to 40cm to ensure adequate moisture profile
- Take care not to plant in hottest summer weather unless you have sufficient moisture and/or you are receiving rain events more frequently

Provide the right soil conditions and nutrition for optimum growth

- Progardes® Desmanthus prefers clay-rich soils with a neutral to alkaline pH. Ensure soil pH is tested down to 90cm
- Specific inoculants are available and should be used wherever establishment conditions are likely to maintain inoculant viability, such as sowing into moist soil

Minimise competition from weeds and dominant grasses

- Identify appropriate strategies to minimise competition, e.g., cultivation, fire, and/or registered herbicides.
 Consult your Agronomist and check product labels for up-to-date herbicide registrations and application methods
- Minimising competition will help conserve soil moisture

Control Pests

• Minimise damage of young seedlings from pests

Let Progardes® Desmanthus fully flower and seed in the first season of growth

 As with any establishing pasture species, it is important to let Progardes® Desmanthus fully flower and set seed in the first season. This will ensure a seed bank has been established for future recruitment. Light grazing after seed has set can create more foliage and seed set for next season

When to Plant Progardes?

Moonsoonal Regions

September- mid-January *Key indicators:*

- Soil temperature >15°C
- Soil moisture greater than 40cm by mid-January

Central & Southern QLD Northern NSW

September-November January-February

Key indicators

- Soil temperature >15°C
- Soil moisture greater than 40cm by mid-January
- Note: December is typically too hot to plant

Progardes® Planting Rate Guidelines

To avoid preferential grazing and improve the overall sustainability of your pasture, aim to establish Progardes Desmanthus across the whole paddock and not in selective areas.

Planting rate will depend on the level of seed bed preparation, scarification, and planting method. Agrimix can provide assistance for solutions to your planting requirements. We also recommend that you consult with your Agronomist when planning your pasture mix and preparing your seed bed.

Seedbed Preparation	Application	KG/HA
Prepared seedbed (tillage/spraying)	Seeder Aerial	1.5-2 3
Limited preparation	Faecal Seeding (hard seed only)	2

Scarified - for rapid germination; and

What are the risks to establishment?

Risks

Management options

FOLLOW UP RAIN

Follow up rain is essential for establishment of seedlings Calculate the probability that follow up rain will arrive. In addition to 40cm stored moisture, Progardes® needs 30mm of rain to strike and a further 40mm of follow up (gentle) rains over 3 falls in the following 3 weeks

MONSOONAL RAIN WEATHER PATTERNS

Managing highly variable monsoonal cycles

If rain is received and soil moisture profile exceeds 40cm by mid-January:

- 1. Conserve soil moisture: control /suppress competitor grasses using appropriate, registered herbicides. (Seek advice from your Agronomist and check product labels for up-to-date information)
- 2. Broadcast seeding: seed scarified Progardes_® by air or broadcast at 3 kg/ha
- 3. Alternatively, if not using herbicide to prepare seedbed, bare soil presentation can be optimised by burning then seeding into ash. Note: If not using herbicide, this seeding needs to take place immediately upon soil mositure profile reaching 40cm

LOW RAINFALL AREA

Managing low average rainfall (less than 550mm per annum) Faecal Seeding is the preferred method in low rainfall areas.

HEAT WAVE CONDITIONS

Take care not to plant in the height of summer

PLANTING TOO CLOSE TO A FROST

Complete planting 2-3 months before first frost to ensure plant has time to establish a good root system and set seed
